Kljub temu, da smo po velikosti najmanjši evropski trg z elektriko, trgovanje na promptnem trgu BSP predstavlja enega najbolj likvidnih trgovalnih območij v širši regiji.

Borza BSP SouthPool, kot predstavnik trgov v razvoju, ki so nastali z oblikovanjem novih evropskih držav v 90. letih, je trenutno eden izmed najbolj vpetih trgov v enotni evropski trg v okviru spajanja trgov z elektriko.

Leto 2019 je bilo za BSP SouthPool prelomno, saj smo svojim članom omogočili trgovanje na enotnem evropskem trgu znotraj dneva (XBID) in z dolgoročnimi finančnimi produkti (v sodelovanju z EEX) in tako ponudili celoten spekter standardiziranih produktov borze z elektriko (za dan vnaprej, znotraj dneva in dolgoročne produkte).

BSP SouthPool je pred kratkim praznoval 10. obletnico in s ponosom sprejemamo ugotovitve naših članov, da nam je uspelo ponuditi zanesljivo možnost poslovanja in povezljivost s sosednjimi trgi, ki so tudi del pan-evropskega več-regijskega spajanja trgov.

Pri finančni poravnavi 507 milijonov evrov in skoraj 9 TWh trgovalnega volumna na promptnih trgih borze, kar predstavlja preko 50% slovenske potrošnje, gledamo z optimizmom v nadaljnjo nadgrajevanje kapacitete in dodane vrednosti našim članom, deležnikom in skupnemu trgu elektrike.

Despite being smallest among European power markets in terms of market size BSP SouthPool spot market evolved to one of the most liquid trading hubs in the wider region.

Among the emerging markets coming out of the formation of new European states in 90s the BSP SouthPool market is the upmost integrated into single European electricity market via market coupling projects.

2019 has been a breakthrough year for BSP SouthPool since it delivered to its clients possibility to enter single European intraday market (XBID) and trade with long term financial products (in cooperation with EEX) and by that full offering of PX standardized products (DA, ID & LT products).

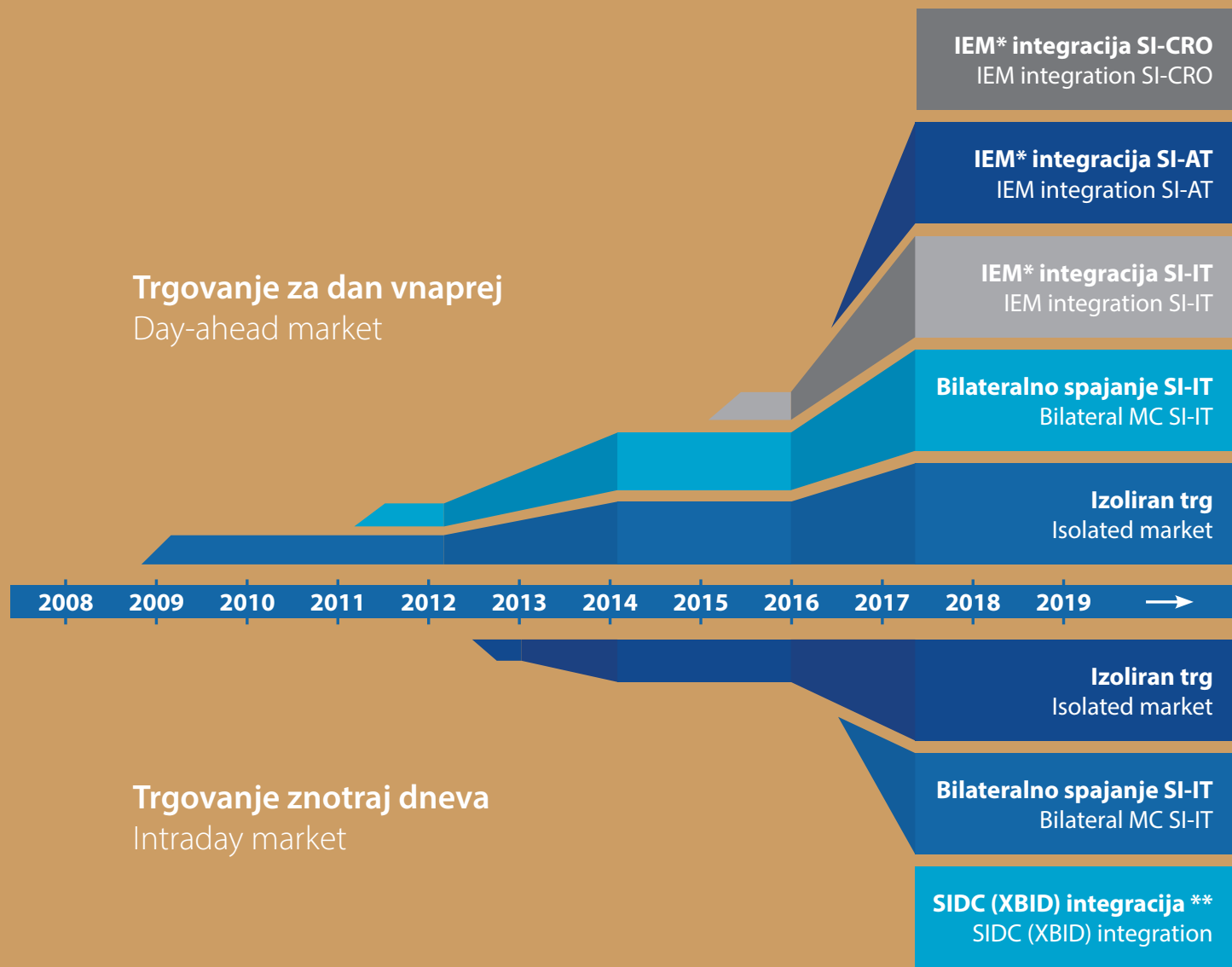
BSP SouthPool recently celebrated its 10th anniversary and we are proud to hear from our clients that we succeeded in delivering a reliable gateway for their business towards other markets taking part in pan-European multi-regional coupling.

After clearing 507 million euro of spot transactions and with almost 9 TWh of traded volume at PX spot markets, representing more than 50 % of Slovenian consumption, we look optimistically into our further capacity building and by that delivering value to our clients, stakeholders and overall electricity market.

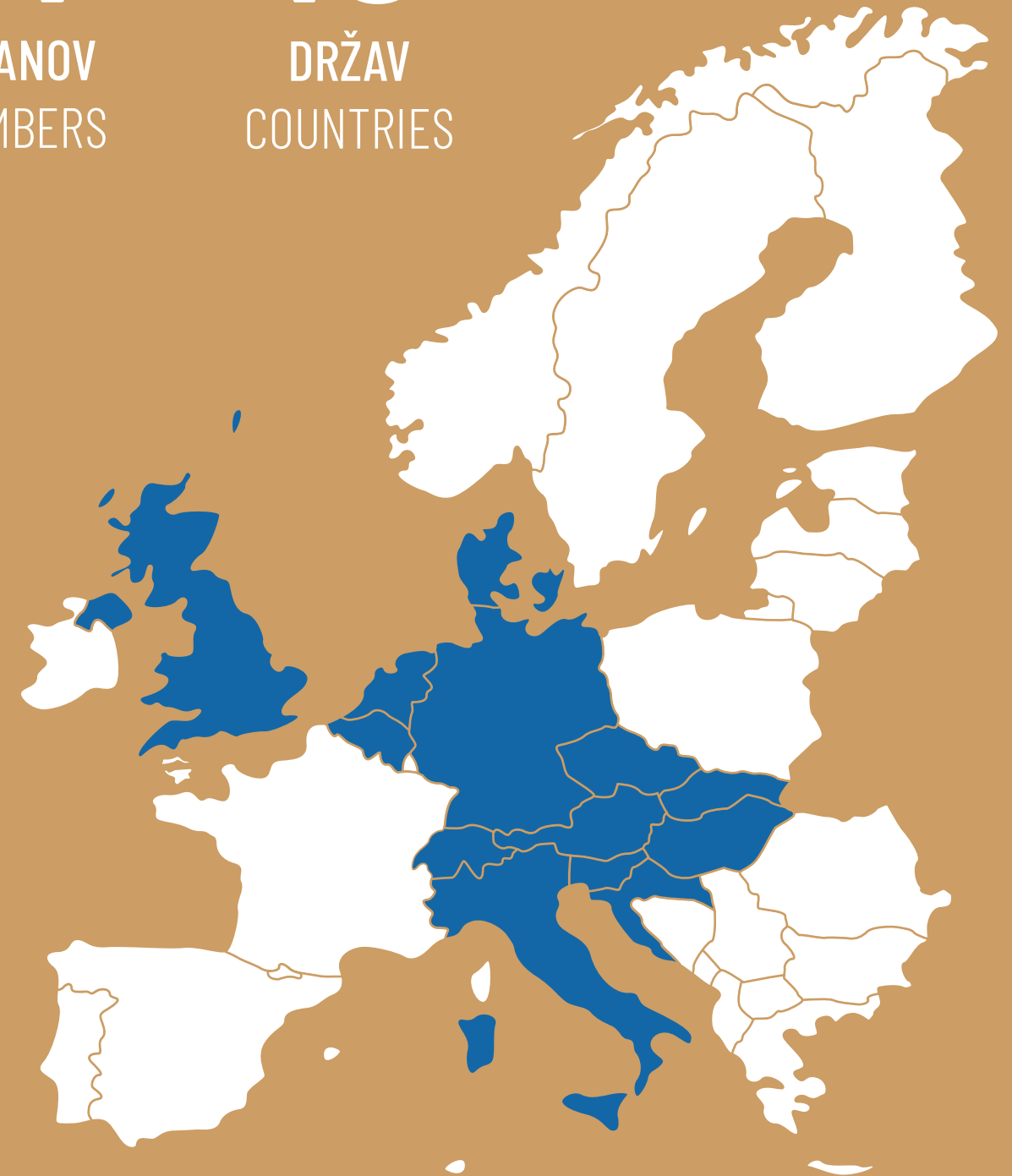

### TRGOVANJE ZA DAN VNAPREJ DAY-AHEAD TRADING

Trgovanje za dan vnaprej na slovenskem borznem trgu poteka na način avckijskega trgovanja, pri čimer tržni udeleženci v fazi trgovanja v trgovalno aplikacijo EuroMarket vnašajo standardizirane urne produkte. Produkti so omejeni s cenovnim razponom od **-500 EUR/MWh do 3000 EUR/MWh in količinskim intervalom 1 MW.**

The Slovenian Day-ahead market is conducted in a manner of auction trading in which market participants in the trading phase submit anonymous standardized hourly products on the EuroMarket trading platform. Products are limited by price range from -500 €/MWh to 3000 €/MWh and with a quantitative interval of 1 MW.



### TRGOVANJE ZNOTRAJ DNEVA INTRADAY TRADING

BSP ponuja možnost trgovanja članom na segmentu znotraj dneva in izravnalnem trgu od 16. oktobra 2012. Sprotno trgovanje znotraj dneva se izvaja na ComTrader M7 trgovalni aplikaciji.

BSP Southpool offered its members a possibility to trade on Intraday and Balancing market on 16th of October 2012. Intraday continuous trading is available via ComTrader M7 trading platform.



### DOLGOROČNE AVKCIJE LONG-TERM AUCTIONS

V zadnjih letih smo uspešno izvedli avkcije za potrebe ELES-a, SODO in tudi za največjega porabnika električne energije v Sloveniji (podjetje Talum d.d.). To definitivno dokazuje, da BSP nudi stabilno trgovalno okolje z zanesljivim cenovnim signalom.

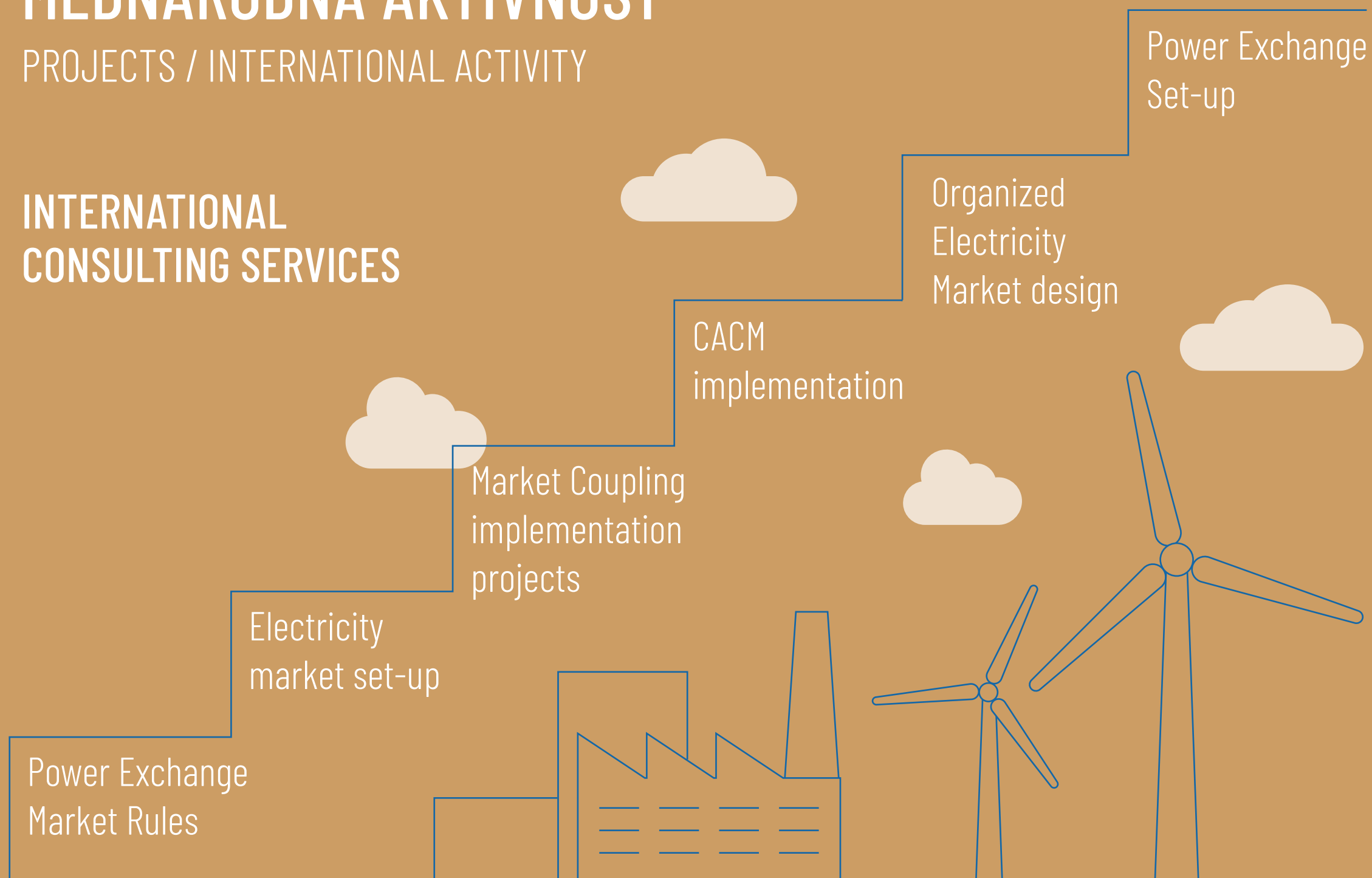

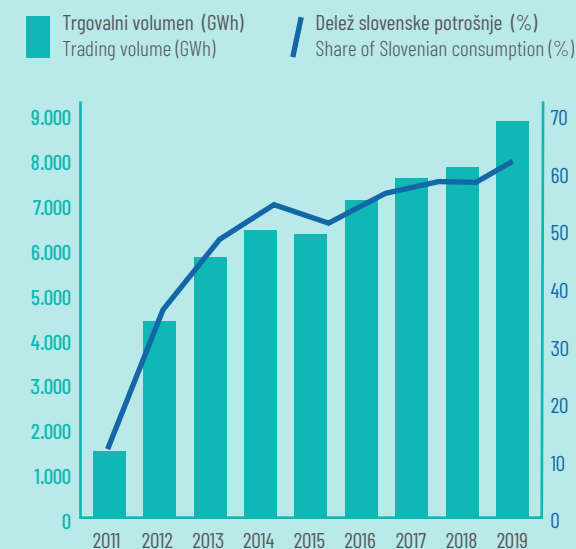
