## 1. General Provisions

BSP hereby lays down the charges for services provided by BSP to apply from 1 July 2024.

#### 1.1. Due Date of Payments

Unless specified otherwise, all fees, reimbursements and possible expenses, including VAT, are due 15 days after an invoice is issued.

#### 1.2. Value Added Tax

All prices in this Price List do not include VAT, and as all BSP services are charged by BSP, they are charged according to the Slovenian VAT legislation. According to the Rules, Transactions are concluded in Slovenia.

#### 1.3. Exemptions

Exchange Members have different pricing for BSP services depending on their market participation.



# 2. Market Data Service

Market data is provided on a Data Portal developed by BSP, enabling manual extraction or connection via REST API.

The market data service fee is charged to the subscriber either in full at the beginning of each year or pro-rata for the remaining months from the month of gaining access to the Data Portal.

Data is shown as soon as it is available on the trading platform and successfully integrated in the Data Portal.
